

On behalf of the San Luis Obispo County Bar Association (the "SLOCBA"), it is my pleasure to offer to you for review the results (the "Report") of the 2021 Judicial Evaluation Poll (the "Poll"). The Poll was conducted via an online data collection program called "JotForm" and was administered by our Judicial Evaluation Committee, Lisa Toke, Gregory Francisco Gillett, and Kevin Elder. The Poll was made available for forty-five (45) calendar days and publicized to all contacts (members and non-members) of the SLOCBA starting on July 26, 2021 with a consistent marketing campaign, including email reminders, social media posts, and mentions during SLOCBA events in order to solicit participation.

We are pleased with the engagement of the local bar, including the thoughtfulness in the responses provided. The Poll responses were anonymous but vetted, via IP addresses, to ensure that each participant submitted only one response. One hundred thirteen (113) individuals participated in the Poll.

We offer the enclosed Report to you and the honorable bench and look forward to any further discussion on how the SLOCBA can assist the bench in continuing a legacy of quality justice in San Luis Obispo County. The SLOCBA is grateful for its relationship with the bench, and we hope the Report will serve as an opportunity for our relationship to grow stronger.

The Report will be posted on the SLOCBA website, and our members will be notified of its availability to review on November 1, 2021. Pursuant to American Bar Association guidance, we will be redacting all comments from the Report that is posted online. The SLOCBA will not be issuing a press release and will not be providing comment to any media outlets that may seek to discuss the Report.





Upon submission, the participants were thanked for their participation and they received confirmation that their polls were received.



Each evaluation was collected by the JotForm program and emailed to the administrator.

LIMITATIONS

The primary limitation of this poll is the size of the sample as it relates to each judicial officer. The overall participation from the Bar was significant and therefore provides validity to the results. However, there are limited sample sizes for some judicial officers who preside over subject matter where counsel is limited (juvenile, small claims, traffic), or where their calendars are primarily administrative. Thus, there are some natural limitations for some judicial officers whose assignments do not call for work within specific categories, i.e., written work product or trials). The Report indicates results derived from small sample sizes by highlighting the results in red font.

Another limitation of the Poll is that it was only offered in electronic format. Although the Poll was compatible with all electronic devices (computer, tablet, phone), there were no paper copies available for completion. However, in addition to the Poll being announced via email, it was posted in the Bar Bulletin and no paper copies were received.


Similarly, some participants may have had technical difficulties when undertaking the survey. However, no requests for assistance were received by the administrator.

The "Overall" score is not the average of the participant's rating for the other categories. Rather, it is the participant's rating of the judicial officer's overall performance.


Responses from computers were more likely to have written comments in addition to ratings.
