#### COMMENTS TO COURT & COURT DATE

"Inclusion of the court date in the "Comments to Court" portion of any e-filed document related to a specific court date. The attorney indicated the filing clerk had indicated it would speed up processing and filing of documents. I have not confirmed this independently, but I have had a filing clerk ask me to include the date on everything I file.

# FEE WAIVERS AND I&Es

"The second is regarding a revision or inclusion to the Fee Waiver Request process. The attorney suggested the filing of an Income and Expense Declaration is always required in Fresno County, and that it is reviewed by the judicial officer prior to making a determination as to the fee waiver. I have generally filed an Income and Expense Declaration when my client is looking for a low income fee waiver, rather than a public aid fee waiver as I have believed that to be best practice. I looked through our local rules and policy and procedures manual, and it does not appear to me to be part of the local requirements."



# CalSearch/re:Search Issues

"1. CalSearch has been unreliable and in disagreement with Attorney Portal/ Odyssey for hearing dates. For example, a matter was set in the morning and afternoon. It appeared correctly calendared through Attorney Portal/Odyssey. It showed only as afternoon setting in CalSearch. I forwarded printouts showing the problem to Anthony Aiello.

2. CalSearch has another problem. I work for a firm. The firm represents all clients who sign on with us. CalSearch does not allow me access to documents in my partner's cases and Visa Versa Everyone at our firm should have access to all documents in all of the firm's cases."

Known gap between re:Search and Odyssey. Court staff have been actively working to address the issue with Tyler. Communicate on weekly basis to resolve issues. This is why the attorney portal continues to be operational. Best workaround for calendaring is to utilize


